1. POLICY STATEMENT

3. Vacancies shall be given as wide an internal circulation as possible to staff who are likely to possess appropriate qualifications or have relevant experience.

4. Specifications for posts shall include only requirements that are necessary and justifiable for the effective performance of the job. Standards of English, education or qualifications higher than a job requires will not be an essential condition for employment. Equivalent overseas qualifications will be acceptable.

5. Any selection test will cover only matters relevant to the tasks being performed.

6. All applicants will be treated equally for the purposes of short listing and interviewing. All interviews shall be thorough, conducted on an objective basis and shall only deal with the applicant's suitability for the job and ability to fulfil the job requirements. Personal or home commitments will not form the basis of employment decisions except where absolutely necessary, for example where requested by the individual.

7. Wherever possible, reasonable adjustments will be made to allow people with disabilities to enter into employment.

8. Staff responsible for interviewing will be clearly informed of the criteria for selection. Guidance will be given on how prejudice can affect selection, and they will be made aware of how misunderstandings can arise between persons of different backgrounds.

4. PROMOTION, TRAINING AND DEVELOPMENT

1. Designer M & E Services UK Limited will not discriminate in respect of promotion and the provision of training courses. Appropriate opportunity for promotion and training will be open equally to all employees.

2. Appropriate training will be provided to enable all staff to perform their jobs effectively. Such training will make provisions where necessary for individuals returning to work following a break for domestic reasons.

3. All staff are encouraged to discuss their career prospects and training needs with their manager.

5. TERMS OF EMPLOYMENT

1. The company will ensure that its conditions of employment do not discriminate against any group of employees and are applied consistently to employees who satisfy the conditions of eligibility. Specific attention is given to ensuring equal pay for jobs of the similar or broadly similar value.

2. Consideration will be given to working arrangements where appropriate to ensure that no employee is disadvantaged by way of personal circumstances or cultural background.

3. Employees who are disabled, or become disabled in the course of their employment, should inform the Human Resources Manager. They may also wish to advise the company of any reasonable adjustments to their employment or working conditions that they consider necessary, or which they consider would assist them in the performance of their duties. If an existing employee becomes disabled every effort will be made to find him or her appropriate work.

6. MONITORING

1. The Human Resources Manager is responsible for monitoring the effectiveness of the equality and diversity policy. Every manager and employee has personal responsibility for the implementation of the policy.

2. Appropriate action will be taken where necessary to redress the effects of any policy or criteria that are found to have unjustifiably limited the provision of equal opportunity.

7. DISCIPLINE

1. Any employee, who discriminates against or harasses another employee, potential employee, or any other individual during the course of his or her employment, on the grounds of age, disability, race, gender reassignment, marriage and civil partnership status, pregnancy and maternity, religion or belief, sex or sexual orientation or any other protected characteristic will be subject to disciplinary action. In serious cases such behaviour may be deemed to constitute gross misconduct and as such, may result in summary dismissal.

2. Disciplinary and poor performance procedures will be carried out fairly and uniformly. If appropriate, reasonable adjustments will be made for employees with a disability in implementing these procedures.

8. GRIEVANCES

1. Any employee who believes he or she has received less favourable treatment on the grounds of age, disability, gender reassignment, marriage or civil partnership status, pregnancy and maternity, race, religion or belief, sex or sexual orientation is asked to use the Company's Grievance Procedure in the first instance.

2. The Company will ensure that any employee making a complaint of unfair discrimination will be protected from victimisation.

3. Designer M & E Services UK Limited has a separate Anti-Bullying and Harassment Policy.

9. TERMINATION OF EMPLOYMENT

1. The Human Resources Department will monitor redundancy criteria and procedures to ensure that they are fair and objective and do not directly or indirectly unlawfully discriminate against employees.
