POLICY STATEMENT

- Continuously innovate in the development of our technology and processes.
- Ensure, a safe place of work and healthy environment including safe plant, equipment, systems of work and arrangements for the use, handling, storage and transportation of articles, materials, and substances.
- Eliminate the risk of performance impairment because of the consumption of drugs, alcohol, and any other intoxicating substances.
- Maintain and develop partner, supplier, contractor and sub-contractor relationships and continually monitor performance.

It is the responsibility of each employee to observe all rules and procedures and co-operate with the Organisation in complying with its statutory obligations.
